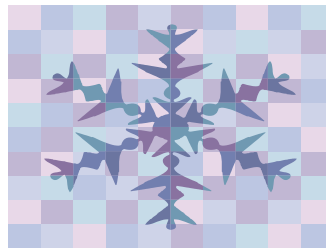
Monthly HOA Board Meeting

General Reminders

The HOA Covenant is an agreement, which covers the rules and regulations that all homeowners agreed to when they purchased their home in the Ridge Pointe Subdivision. This document can be found on the Ridge Pointe Web Site (<http://www.ridgepointefred.org>). If you do not have access to the Internet please contact a Board member and they will help you obtain a copy.

The Covenant should be consulted before making modifications to the outside of your home and in some cases the inside, this includes, but is not limited to sheds, fences, additions, decks and any structural changes. Before building or installing sheds, fences, additions, decks or other improvements you must submit plans and a formal request to the Architectural Review Committee. One correction, the Covenant states there is a fifty dollar fee required when submitting a request, that fee is no longer charged, all re-

Trash containers may be placed curbside the night before trash pickup. Once trash has been picked up the containers must be removed from the curb and stored out of plain sight (ie inside your garage or behind your house). Containers may not be left out for multiple days.

Please keep in mind that the covenant states that all homeowners should keep their property from becoming unsightly. This includes unattractive growth, accumulation of garbage or debris, and keeping structures in good repair and painted on a regular basis. This is not meant to be an unnecessary burden, but to be a benefit to all homeowners and their property values.

General Reminders Continued

As per Stafford County ordinance, all dogs MUST be on a leash. Even though Fido may be the nicest fellow, your neighbor (or neighbor's dog) might not think so. Also, please show consideration towards your neighbors by picking up after your dog.

Please remember the speed limit in the neighborhood is 25 MPH. Safety for our members comes first. "Drive as if your children play here."

In an effort to keep our neighborhood beautiful please please pick up (pick up) any trash that may be on your property, adjacent to, your property, or in common areas. Let's all make the time to beautify Ridge Pointe.
